Students may transfer an unlimited amount of credit from Southwestern, and must complete a minimum of 45 credit hours from OU to meet degree requirements. As programs may limit how much transfer credit can be used toward requirements, it is highly recommended that students work with both an OU academic adviser and their Southwestern academic adviser to maximize the applicability of coursework to specific requirements.

TRANSFERRING WITH THE MICHIGAN TRANSFER AGREEMENT (MTA):

When choosing to complete MTA to satisfy General Education, please confirm the best courses to take to fulfill the agreement with your academic adviser at Southwestern or at the <u>Southwestern MTA Approved Courses</u> website. Completing MTA when following this major guide will satisfy OU's transferable General Education requirements.

NOTES:

Transfer students are admitted directly to the major if they have a cumulative GPA of 2.8 or higher, if students have a GPA between 2.5 and 2.79, they are admitted as a "Candidate" to the SECS, and will need to meet established criteria to change their major.

Students apply for major standing once they have completed math, science, and core engineering courses.

Oakland University will always honor the **MACRAO transfer agreement** and apply it to the General Education requirement the same as MTA.
