- 2. Welcome/Introductions
- 3. Peggy Cooke- Provost Office, Outstanding AP Award Committee
 - a. There was talks about not having the past AP Award recipient plan the following year's process, but instead forming an Outstanding AP Award Committee.

- 4. Approval of minutes from September 26, 2013
- 5. President Report
 - a. We have a thank you card for Dr. Russi for his time at OU. Please sign it and give your thanks if you wish.
 - b. We have a shared account for AP Assembly now. This way we can share our documents from year to year which will aide in our transitions.
 - c. There has been a suggestion to merge the AP Assembly and the AP Association. Shaun has spoken to the AP Association President Greg Jordan about retrieving old documents as to why this has not happened in the past.
 - a. The AP Assembly is a recognized body by the university. The AP's sit on the Senate and are recognized by the Board of Trustees. The AP Association is supposed to serve as a provisional union. Every AP is automatically part of the Assembly, but not necessarily the Association. In the past few years we have not had many large issues that the AP Association had to fight for, but if there were and we merged the two the thought would be that we might enter in trouble.
 - b. Part of the confusion is that there are not clear distinctions between the two organizations in marketing. The two names are very similar, so do we change the names to signify what each organization is doing?
 - c. The AP Association is really meant to speak for the AP's rights in case there are major issues. The AP Association used to charge dues as well, which have not been collected for the last few years. The dues went to The Ultimate Fringe Benefit too, which has not taken place for at least the last 2-3 years.
 - d. Shaun plans on continuing to meet with Greg Jordan to have these conversations.

6. Vice President Report

- a. Petra is planning the New AP Welcome for March 2014 from 3:30-5:00pm. If you are interested in serving on this committee, or if you have new ideas, please let Petra know.
