The Academic Conduct Committee (ACC) is charged with investigation of cases of academic misconduct at Oakland University, and with the responsibility for imposing sanctions upon those found quilty of violations. During the period from summer term 1992 through spring term 1993, the committee heard a total of 26 cases, involving 42 students. This represents an increasing trend during the last three years:

Of the cases heard, 22 or 85% resulted in a guilty verdict; of the students charged, 27 or 64% were found guilty. Both of these figures suggest that in quantitative terms, the committee has been receiving well-prepared cases from the faculty members involved and has been able to deal with them accordingly.

#### Committee Caseload

During the last year, cases have been quite widely distributed throughout the academic units of the university:

This shows a campus-wide consciousness of academic conduct issues. Among the cases brought before the committee the majority (18, or 67%) were for cheating on examinations or other exercises. Plagiarism was the second most frequent charge (8 cases, or 30%). There was one charge each of falsifying records and of unauthorized collaboration. The caseload distribution by term is as follows:

#### Sanctions

The committee has a range of sanctions that it may impose on guilty parties including a reprimand, probation, suspension, and expulsion. Of the 27 students found guilty, the penalties were distributed as follows:

Periods of suspension ranged from one term to two years (for a repeat offender). Suspendees are also on academic probation for the remainder of their Oakland career.

#### Other Developments

During the last year the Steering Committee of the University Senate revised its procedures for hearing appeals of ACC cases. The chair of ACC was able to make suggestions, and is most grateful for having been consulted. The resulting procedures clarify very well the appeal mechanism. The committee is proud of not having had any of its decisions overruled on appeal.

Last year the issue of cheating was raised in the <u>Oakland Post</u> (see attachment). The chair of ACC was interviewed and thus given an opportunity to spread awareness of the committee's existence and function among the student body. Disturbing, however, was the story's revelation that of the students surveyed (not all of whom were from Oakland University), 54% had cheated in classes. A common method of cheating--programming formulas into calculators--mentioned in the article has never caused a case to be brought to ACC, in spite of its popularity.

A memo describing the function and procedures of the ACC was distributed to the University faculty during the winter term. Thus the last year saw increased awareness of the committee and its work throughout the campus community.

#### Directions for the Future

The continued cultivation of this awareness should be a principal concern of the committee. We may want to publicize the ACC among the student body more than we currently do. The committee can serve as well to focus faculty attention on issues of academic misconduct, including such new and improved methods of cheating as come on the horizon.

#### Acknowledgements

The committee would be unable to function without the superb administrative support of the Dean of Students Office, which collects the statistical information on which this report is based. Nancy Schmitz is highly effective at organizing our schedule and making sure that committee members have all of the necessary information before the meeting starts, ably assisted in these by the redoubtable Jan Baker and Shirley Miles. David Herman, in his invaluable presence as a committee member himself, is a superb source of guidance and informed decision making, serving, among other things, as the institutional memory of committee.

The hearings themselves are arduous indeed; the responsibility of sitting in judgment is felt by all to be a grave one. Those who served on the committee this year carried out its charge with dedication, sensitivity, and fairness. Our faculty members were Lawrence Lilliston, William Fish, Ren-Jyh Gu, Sadi Bazaz, Michael Latcha, Billy Minor, Subbaiah Perla, and Jane Walter. Our student members were Chander Nijhon, Heather Nicholson, Staci Savage, and Dawn Aubry who now leaves the committee after several years of much-valued service. Thanks to all for a job well done.
