1. Committee approved Minutes #4, October 11, 2012.

- 2. Committee approved the request from the Department of Art and Art History to **add** a new
- DES 355 Web Design II (4)
  Advanced web page design techniques including scripting and site design issues such as scalability, maintenance, and integration of web technologies into business and organizational context. Prerequisite: DES 330 with a grade of 2.8 or higher.
- 3. Committee deferred the request from the Department of Art and Art History to **add** a new course:
  - DES 480 Graphic Design III (4) In-depth individual and group studies/critiques as students work on coherent body of professional-level design work. Prerequisite: DES 350.
- 4. Committee deferred the request from the Department of Biological Sciences to:
  - a. **Change** the *course credits* from (5) to (4) and **delete** *Includes laboratory experience* from the *course description* for BIO 311, Botany.
  - b. Add a new course:
    - BIO 329 Principles of Pharmacology (4) Introduction to the general principles of pharmacology. Includes principles of drug action, drug metabolism, and a review of major classes of pharmaceuticals. Prerequisites: BIO 205 and 207, or BIO 315 and 321, or BIO 325, or BCM 453, or CHM 453.

Draws on core concepts from media and cultural studies to understand and analyze popular music's relationship to social and culture production. Key debates discussed include cities, technologies, gender and sexuality.

A grade of 2.0 or higher must be achieved to satisfy the university general education requirement in the writing knowledge foundation area.
