#### **MINUTES**

- 1. Committee approved of Minutes #2, November 13, 2014.
- 2. Committee deferred the request from the Department of Biological Sciences to **add** the following *new courses*:

BIO 593 Integrative Pharmacology (4)

Introduction to human pharmacology with emphasis on an integrative approach to encompass clinical application, physiological functions, pharmacological principles, biochemistry of actions Offered fall semester. BIO 593 is cross listed with an undergraduate course, BIO 493. Students cannot receive credit for both courses.

BIO 566 Medical Parasitology Lab (1)

Lab course with associated lecture (BIO 565). Study of medically important protozoan helminth, and arthropod parasites, including their morphology, biology, pathogenesis, clinical manifestations, immunology, epidemiology, and control. Lab activities include methods for identification of medically important parasites. BIO 566 is cross listed with an undergraduate course, BIO 466. Students cannot receive credit for both courses.

# **Master of Science in Chemistry**

Thesis Plan

- CHM 690 Graduate Research (8 to 20 credits)
   The candidate for the thesis plan Master of Science in chemistry must complete 32 credits in courses carrying graduate credit, of which 24 credits must be in chemistry.
   Courses with 400-level numbers may be included providing they do not duplicate courses in the student's undergraduate degree. It should be noted that credits for 400-level courses are exempt from financial assistance (federal) in the graduate program.
- 6. Committee approved the request from the Department of Linguistics to make the following **changes** to *catalog copy*:

## **English as a Second Language Endorsement**

Change the program title to *Teaching* English as a Second Language Endorsement and refer to the program as "TESL" rather than "ESL" throughout catalog copy.

Introductory paragraph

The Oakland University Teaching English as a Second Language (*T*ESL) Endorsement program is a joint effort between the College of Arts and Sciences' Department of Linguistics and the School of Education and Human Services. The program has received approval from the State of Michigan Board of Education to offer *a T*ESL Endorsement to teacher certification. The program consists of 20 credits taken in five four successive semesters.
