Dear Current Oakland University Scholar: If you plan to transfer from another U.S. school to OU, you must fill out this form and schedule an appointment to notify ISSO of the school to which you plan to transfer. Upon receipt of this form and your new offer letter, we will update your record in the SEVIS System as a "transfer out" and indicate the name of your new school and the transfer release date. Your new school will not be able to issue you a new SEVIS Form DS-2019 until the transfer release date. The transfer must take place within 30 days of the DS-2019 program end date. In order for us to transfer your SEVIS record you need to bring an offer letter from your new institution. *Please

Note: you may not be employed at OU after your transfer out date.
