- 3. Health Sciences, B.S., Concentration in Foundational Health Modification Proposal
  - Amanda Lynch and Ed Rohn
    - a. Rationale
    - b. Curriculog
    - c. COI Minutes
    - c. COI (Electronic Vote to change name of concentration)
    - d. Catalog Copy
  - Provides a fourth and more flexible concentration for SHS
  - Provides a pathway for students who change their intention for professional schools; reduces the need for POE's and make things easier for students to complete program in a timely manner

<u>COMMENT</u>: Positive alternative for students who decide to change majors <u>COMMENT</u>: Consideration of health science major without the option of a concentration; not having the requirements may offer more flexibility <u>RESPONSE</u>: Major is currently written that a concentration is required; program review will be next year followed by an evaluation of restructuring the program. This is the most straightforward option at this time to help students. This meets an immediate need.

<u>RESPONSE</u>: This concentration will provide marketability for students <u>COMMENT</u>: The changes in building curriculum at last minute is a lot of intentional work for a possible brief period of time

<u>RESPONSE</u>: Many students are changing their majors and that presents an immediate need while the department reevaluates the major - preventing loss of students and a way to help guide them

<u>COMMENT</u>: Rationale – (a student failing chemistry) - are there other concentrations that could be taken? Does this concentration waive these failed courses? Does this pose a detriment to the student?

<u>RESPONSE</u>: There is a (1) pre-health concentration that is science heavy and (2) holistic health that is lighter requirement and a (3) pre-pharmacy for those going into pharm

RESPONSE: This concentration does not require chemistry but does require physiology / chemistry is an "option"

<u>RESPONSE</u>: There is a shift in the pre professional requirements (more microbio rather than chemistry)

<u>COMMENT</u>: Current students under prior catalogs in the pipeline, what is the plan?

<u>RESPONSE</u>: Students can update their catalog year and update with advising if it makes sense for the student

<u>COMMENT</u>: Concern that a system is in place to alleviate additional requirements that put burdens on a student

<u>RESPONSE</u>: "I don't think so" – this was designed with this in mind/ this was designed to have students easily transition to not lose any courses and still graduate with a concentration

<u>COMMENT</u>: Concern this has an unintended consequence for students – students not taking the more difficult courses to maintain a higher gpa may face challenges later on

<u>RESPONSE</u>: More likely, this provides a route for students who change their intended direction to not attend professional schools – advising addresses the long term goals for and with students

<u>COMMENT</u>: Anything to get rid of POEs is great, however, if the dept is going to change in the future, it will have to change the code and that will cause system issues / could this be considered a specialization

<u>RESPONSE</u>: Students need an option to proceed with a flexible option /code will remain forever when the concentration no longer exists

<u>COMMENT</u>: Statement in the catalog that students are required to take courses from the SHS is vague

RESPONSE: Advising guides students with SHS courses

<u>COMMENT</u>: Catalog copy issue – words do not reflect what the concentration truly is about

<u>COMMENT</u>: Less about OU losing students and more about leaving SHS to BIS or other depts / or is the concern students leaving OU

<u>COMMENT</u>: Should OU provide a better option for students or an easier option to graduate? Does this concentration meet the goal?
