- 5. Curriculum Definitions for Governance Draft- Kristin Landis Piwowar
  - These definitions are specific to undergraduate curriculum
  - Major with Specialization Reviewed
  - These are definitions that faculty and staff will use to create curriculum / not for student perusal
    - Will be providing a glossary for students in the catalog
    - These will be housed within ERN and greater vision is also to be housed in a Curriculum Facilitation Website within ERN

- Degree Works concerns were reviewed / no concerns
- Minor no more than 24 credit hours / the shape of the definitions do not coincide
  - Motivation for a cap on credits on a minor
  - Any need to consider allowing language for more credits?
  - Reasoning is that OU is creating minors that are attractive to students and coincide with what the purpose of a minor is to increase knowledge and marketability for students (not just additional credit hours + costs)
  - 24 allows for current minors to remain / longer term goal to keep this number lower for students
- Majors with a Specialization
  - This was reviewed with SECS (connected to definition)
- Minor
  - Change 2 courses to 6 credits for consistency
  - 50 percent of credits to be taken at OU
  - Align with Major definition
    - Discussion: Do you need a degree from OU to earn a minor / could a student be a PB and come back to receive a minor? Or similar circumstances? Student with undergrad from a different university coming to OU to complete just a minor?
- Major
  - Added 50% of credits required to be taken at OU
  - o BIS = 32 credits at OU (these are all major requirements)
  - o This is an audit process already in place

  - Bringing forward updates
  - Lining up course numbers so that grad and undergrad are symmetrical/ changed grad numbers to match the undergrad numbers
  - Cleaned up catalog descriptions / shortened as per UCUI request
    - Added phrase to cover double counted courses / not all undergraduates can take the double counted courses, only those admitted to the program
  - General management students / can take any courses within the SBA
  - COMMENT: Courses have gone through Grad Council for changes
  - COMMENT: Would not use certificates within an additional major need to change the description per the "Response Document"
    - COMMENT: Change to "earning an additional major"
    - o RESPONSE: This is added for all of the SBA degree programs
    - COMMENT: This needs to be corrected and consistent with the remainder of SBA programs
  - COMMENT: Clarity makes this so much easier for students and advisers to understand

- 9. Communication B.A. and Journalism B.A. Rubric Change Proposal, Department of Communication and Journalism, College of Arts and Sciences Kathy Battles & Beth Dawson
  - Revising two undergraduate majors Communication & Journalism
  - Not adding anything new
  - Reallocating how courses are organized; existing faculty resources and courses between programs in the dept that will offer significant improvements

- Change name of Journalism to Journalism and Media Studies / changing rubric for all journalism courses and communication courses that are moving over to this program (JMS is the new code) / the numbers are not changing
- Cross-listed production courses will be dropped after this goes into effect
- Not changing titles or courses
- COMMENT: How many majors will there be?
- RESPONSE: 3 majors: Communication Major will be more focused with these changes / Journalism and Media Studies will allow a more robust media program / Public Relations Major
- RESPONSE: The Journalism Major will no longer exist and be changed to Journalism and Media Studies in the near future
- COMMENT: How will this affect current students enrolled?
- RESPONSE: Because the courses are not going away, current catalog will not be affected
  at all / Communications moving into media production and social media creation will
  now be able to do this within this new major / Journalism was only directed to
  journalism and this now allows space beyond just journalism
- COMMENT: Are current courses deactivated? DegreeWorks and advising what is the timing?
- RESPONSE: Ending the JRN and to begin the JMS in the 2023 catalog / especially important because schedules are due now / rubrics are due now / plan is to end-date the courses
- COMMENT: Process to end date and then instate new letter codes from JRN to JMS
- RESPONSE: This is a positive change for department and greater options for the students
- COMMENT: Dept is in the process of changing the name of the major
- RESPONSE: The major name change will be coming forward to another meeting / specializations are in the works (waiting on wording) based on previous suggestions
- COMMENT: Appears simple, but could be complicated for students
- COMMENT: Appreciation for the recognition of what happens to make this type of change / not a reason not to move forward but pause to make a determination of when this actually makes sense / 5 years of extra effort when this occurs
- COMMENT: Could the courses be cross-listed? Would that be a helpful solution to the students?
- RESPONSE: As this is built in DegreeWorks, cross-listed courses becomes a management task to fill both courses and this practice is against OU policy
- RESPONSE: As long as courses are set up as equivalencies, this is manageable
- COMMENT: Is the process typical for the rubric to be changed first?
- RESPONSE: It would make sense to bring together; this instance is awaiting approval of definitions
