## **OLD BUSINESS**

- 2. Proposal for New Minor in Communication, Advocacy and Social Justice (Kathy Battles/Beth Dawson)
  - A) COI Minutes
  - B) Curriculog Proposal
  - C) Updated Proposal
  - Course that was part of original proposal was removed until course is approved - this course does not affect the credits of program
  - All courses are already offered with updated proposal
  - This minor is not open for communication majors
  - Minor offers students from all areas of campus this area of study; complements other coursework

<u>GOAL</u>: Teach students to think critically about persuasion and construction/empower advocates

<u>QUESTION</u>: Is the repeat of courses in both "required" and "elective" going to be confusing?

<u>RESPONSE</u>: Keeping in both places, allows the third course an option <u>RESPONSE</u>: This is common practice and should not be an issue for

students

**QUESTION**: Persuasion and Social Change vs Persuasion –

RESPONSE: Political and Social Change Persuasion focuses on history of social movements (advertising, creation of communications, etc.)/
Persuasion covers different approaches and science of persuasion
RESPONSE: Combination of courses will provide framework
QUESTION: Three (3) courses are important for minor – will a student miss out if they choose (2) of the (3)?

<u>RESPONSE</u>: The electives will provide engagement with issues of communication and diversity and created to be woven in curriculum and offered regularly

QUESTION: Electives 3,000 – 4,000 level courses; can a student get away with taking the lower level courses instead of the higher level courses?

RESPONSE: Required at least one 3,000 level course – if committee feels the need of higher level courses, it could be returned for review QUESTION follow up: This is more about the level of material required RESPONSE: Relatively easy to make a change to require at least one course at higher level (3,000)

Deferred for changes: (1) addition of 3,000 level course requirement, (2) COI Update of removal of new course that is not yet offered, and (3) COI Approval / Will return to UCUI

## **NEW BUSINESS**

- 3. HiSET for Admission Purposes (Presented by Shane Lewis; Kelly Flemming, Amy Tully)
  - Potential addition of HiSET for incoming freshman as alternative high school equivalency exam
  - 2016 Public Act 249 approved high school equivalency tests including HiSET
  - First groups of adult learners are now requesting admission to OU
  - Currently only allow GED at OU
  - Great opportunity to support students and support Mich Governor in
  - Increasing higher options and access
  - Promotes options and access for students
    - Paper testing option
    - GED is not offered in all states; we can offer admission to other out of state students
    - College readiness is met with the standard set by OU

- HiSet is approved at many Michigan higher education institutions
- Under consideration at Michigan State

<u>QUESTION</u>: What if is a student does not meet the minimum requirement on HISet or GED?

**RESPONSE**: Support is provided to recommend a plan for community

college and create a transfer pathway to OU

QUESTION: Why is it not implemented at OU yet?

RESPONSE: Relatively new – jut now seeing the test takers ask for

admission / needs to go through institution governance
