Hi Charlie,

This is to confirm ABET's understanding that the current OSH program is currently accredited through September 2018 and that your plan is to terminate that program effective January 2016. Given the termination is not synchronous with the next review date you would need to submit a termination plan now that demonstrates the program's ability to continue delivery of the accredited program during its phase out to cover all students graduating from that program after January, 2016 to the end of the current accreditation period of September 2018.

Once the termination plan is received it will be reviewed by 2 commissioners from the ASAC Commission and their recommendations will be reviewed by the ASAC ExComm at their next meeting in April of 2016 who will determine at that time if students graduating after January, 2016 are covered.

The program will continue to be listed as accredited and then in the 17-18 review cycle, ABET understands that Oakland will be submitting a "new" program whose name will allow it to be reviewed using the EHS Program Criteria along with the ASAC General Criteria. ABET understands that this is the "same" program currently offered at Oakland but ABET's policies require this process to accredit the program with a new name and new Program Criteria.

Subject: Program Termination By Institution

Following is the Termination Plan required under Section II.I.I.c. of the ABET APPM. This termination plan clearly demonstrates our OSH program ability to continue delivery of our accredited program during its phase-out.

Currently there are 94 declared OSH majors. We expect many of these students to change majors to EHS in the Winter 2016 semester which begins on January 5, 2016. However, students will have the option to complete the OSH degree program per Oakland University policy which allows students six years to complete degree requirements. The current OSH program is accredited through September 2018. All current OSH majors will be sophomore to senior status by the end of the Winter 2016 term and should graduate not later than December 2018.

The EHS major will not be available to students until the Winter 2016 term begins. An accurate count of OSH majors remaining after students are allowed to change majors will be provided prior to the ASAC ExComm meeting in April 2016.
