## BIO 593 Integrative Pharmacology (4)

Introduction to human pharmacology with emphasis on an integrative approach to encompass clinical application, physiological functions, pharmacological principles, biochemistry of actions Offered fall semester. BIO 593 is cross listed with an undergraduate course, BIO 493. Students cannot receive credit for both courses.

## BIO 566 Medical Parasitology Lab (1)

Lab course with associated lecture (BIO 5650). Study of medically important protozoan helminth, and arthropod parasites, including their morphology, biology, pathogenesis, clinical manifestations, immunology, epidemiology, and control. Lab activities include methods for identification of medically important parasites. BIO 566 is cross listed with an undergraduate course, BIO 466. Students cannot receive credit for both courses.
