## FAFSA Workshop Checklist

For the 2015-2016 FAFSA you will need financial information from the 2014 calendar year. If you and your parent(s) have not yet filed taxes, bring your 2013 tax information to estimate.

If you can answer "YES" to any of the following, you do NOT have to bring Parent information:

- ✓ I was born before January 1, 1992
- ✓ I am married
- ✓ I am serving in active duty or am a veteran of the U.S. Armed Forces
- √ I have children/dependents
- ✓ I am an emancipated minor or I have a legal guardian who is not my parent
- ✓ I have been declared a homeless or unaccompanied youth
- ✓ After I turned 13 years old I was orphaned, in foster care, or a ward of the court

You will need to bring the following information with you to the FAFSA Workshop:
